**Privacy information pursuant to Art. 13 of the EU Regulation n. 679/2016 ("GDPR").**

The **Data Controller** is **Centro Estero per l'Internazionalizzazione S.c.p.a.** (hereinafter "**PIEMONTE AGENCY**"), located in Via Nizza n. 262/int. 56 - 10126 Turin (TO), in the person of its President.

The interested party can write to the DPO for any question concerning the processing of their personal data, as well as to exercise the rights pursuant to Articles 15 and ss. of the GDPR.

The personal data provided, such as those of contact, are processed:

- a)** according to the adhesion to the event, based on a task of public interest (Article 6, paragraph 1, letter e) of the GDPR) carried out by PIEMONTE AGENCY, as per the Statute approved in implementation of the Law of the Region Piedmont n. 13 of 13 March 2006;
- b) to send strictly limited information to similar events promoted by PIEMONTE AGENCY**, based on any consent given.

The provision of data is voluntary. Failure to provide data will make it impossible to attend the event; failure to consent to the purpose sub lett. b) just prevents the sending of informative communications by PIEMONTE AGENCY.

The processing will take place for the time strictly necessary for the pursuit of the purpose, in compliance with the principle of minimization, as well as for additional periods compulsory by law and for administrative reporting and follow-up purposes.

The data may be **communicated** by PIEMONTE AGENCY, or in any case they may become aware of it, third parties with whom there are contractual service relationships, external data processors appropriately designated by the Data Controller and appointees authorized for that purpose and instructed, in addition to the members of PIEMONTE AGENCY, based on the legal and contractual obligations of the Data Controller, both in Italy and in Europe. In any case, the data **will not be disclosed**.

The person concerned is always guaranteed, **in particular, the exercise of rights**: access and rectification, deletion of data after the period of conservation required by law, limitation of treatment in case of opposition request, to revoke consent to treatment without prejudice to the lawfulness of the processing carried out before the revocation. He will always have the right, finally, to make a complaint to the Data Protection Authority.
